- b) Criteria have been developed to consider the primary positive characteristics of each fleece type to be evaluated.

c) One hundred points are possible. The judge will identify tie breaker categories, in order, for each division or class, prior to judging. Categories to be included in the judge's choice of order are fineness, hand, and luster.

"We recommend that it be changed to read, "A judge may not adjudicate any animal which has been purchased from said judge or his/her immediate family within 12 months of the date of the show where the judge is officiating."

It was suggested that fleece judging clinics could be 2 days instead of 3 days.

The budget will dictate how many people would need to attend a clinic, there is not a minimum number set by ILR on how many people need to attend the clinic.

As an FYI, the judges committee has been made aware of some very negative comments that were made at a major show by one of the judges. They have discussed this issue and sent out an e-mail blast encouraging judges to be more positive in their evaluation of all llamas, as everyone has paid their entry

fees, and worked hard to participate at the shows, and we owe it to them to not be too negative in our comments.

### Performance Committee Report: Debbie Arendas

The performance committee is dealing with an issue that is going to require input and help from the Governing Board. The performance committee has had a phone conference to address the issue, and we have made a unanimous decision to present to the GB.

Background info: On July 16th the PC received an email from an exhibitor with a question of clarity as to what division they should show in (novice or advanced) in an upcoming show. Said exhibitor won a Reserve championship in a dual sanctioned show (ILR & ALSA) in which they entered both shows and won Reserve in both in the fall of 2017. They also won a Grand in another show that fall and a Grand at the Gathering. The Guidelines state that when an exhibitor wins 4 Grands and/or Reserves in any performance division in any Show Assoc with a minimum of 5 in the division they move from novice to advanced. The exhibitor did not think this should count for them as when they won the dual sanctioned show they only went thru the course one time under one judge. But they paid to enter both shows and get points from both show associations. In all the shows there was more than 5 in the division.

The exhibitor did not say when the upcoming show was. At that time I was preparing to leave on Wednesday morning for Ohio State Fair Show of which I am the superintendent, and figured I would deal with it after the show. Yep - it was the Ohio State Fair show they were talking about as their upcoming show. The dual championship was won in the fall of 2017 and the deadline for Ohio State Fair was June 20 for which was held July 19-21. Why the exhibitor waited until 3 days before the show to ask this question I do not know.

The exhibitor and I discussed the situation at the show on Thursday before any classes started. I needed time to think this over and decide what to do. Discussion with the other PC members was not an option. On Friday morning at least an hour before classes started I again discussed the situation with the exhibitor. They wanted to know what I wanted them to do. I told this person that with their experience as a judge, former ILR board member, former ILR GB committee member and a seasoned exhibitor I would not make their decision for them. They should know what to do more than I. I told them another exhibitor had already moved their animal to advanced when they arrived on Thursday as they were in a similar situation. The exhibitor was told to go to the show office to move their animal if they so desired. If they did not I would take that as their decision to remain in novice. The exhibitor did not move their animal.

Upon returning from the state fair the PC met in a phone conference to discuss the issue. After discussion and research the Performance Committee reached a unanimous decision that the exhibitor should have moved their animal to advanced and that there should have been no doubt on that issue. That animal also received a Grand in performance at the state fair. It is the committee's wish to have the GB remove the animals placements, awards and titles from them for the Ohio State Fair show as covered on page 23; Section 6; Item 4 of the 2018 Guidelines. Furthermore the animal is only to be shown in advanced performance.

The Performance Committee has not contacted the exhibitor with their decision yet pending the GB's decision on this situation also. Please advise as to how we should proceed.

The issue was brought up that as cases like this are made aware the same precedence should be followed. It was also mentioned that superintendents remind everyone the rule on moving animals up to advanced and the consequences if an animal is not moved up at the appropriate time.

Per the Guidelines, Page 23, Section 6, Item number four: Animals shown in the inappropriate division will have any Placements, Awards, and Titles removed from them by the Governing Board.

The Governing Board will send an e-mail to this exhibitor letting them know of the rule and consequence.
