The judges committee discussed a request from Megan Bixler to become an approved judge in HPY. The committee agreed Megan would make a good judge. Fran motioned to approve Megan as a judge in HPY. Nick seconded. Motion passed unanimously. Steve will send the recommendation to the Governing Board.

The following fleece clinic attendees were approved as fleece apprentices by the committee and the Governing Board via email.

It was discussed how many apprentices a teaching judge could have at an event. There is nothing in the guidelines regarding this. Nick suggested advising teaching judges on how many is recommended in the upcoming newsletter.

Jerrika discussed name tags for ILR-SD judges. The ILR does not currently send them to judges. It would give judges a professional identification to wear at shows at a small expense to the ILR. Steve will bring the suggestion to the Governing Board.

Fran discussed an apprentice evaluation received on an old form. Steve will include in the newsletter that there is a new form for apprentice evaluations on the ILR website.

The next meeting was set for Thursday, September 21st at 7 pm central time. Fran motioned to adjourn the meeting. Cathie seconded. Unanimously approved. Adjourned at 7:38 PM CDT.
