Minutes from the previous meeting were approved via email.

#### Office Report - Susan Hannah

- Susan is getting complaints about the turn-around time for paperwork. She suggested sending out
  an e bulletin explaining that we no longer have the staff we used to have and the turnaround time
  would be a little longer.
- Need to order certificate envelopes. Susan suggested 5000. Sean motioned to only buy only 2500 envelopes. Motion carried.
- Susan suggested we consider square instead of PayPal, for credit card transactions. However, if
  Square is used all transactions would need to be run at the office. Dawn indicated that PayPal
  had a Pro feature that has a virtual terminal, so we could process credit cards anywhere and take
  on-line payments. Paul has indicated that it would cost \$1400 to make the changes. Harvey to
  send Paul an email regarding charges to the website and credit card processing. Also suggested
  we get another opinion from Steve or Jerry regarding a better easier way to take credit card
  payments online. Harvey and Dawn to move forward with conversion to PayPal.
- Susan suggested that since next year is our 30<sup>th</sup> anniversary, we offer a blanket \$30.00 registration for any animal over 12 months. The BOD was in favor of this idea.
- Susan indicated that there is interest in someone buying the planters. BOD told her to sell them.
- Changing fees is not as easy as the BOD thought and right now we do not have a programmer to
  program Lama Registry and the transaction report to lower the breeder fee or create a 5 year
  membership. Most of the meeting was spent discussing the programming needed and how
  systems within the ILR "talked" to each other and interacted, making any change quite complied.
  Work-arounds can be created in the transaction report for the lifetime membership, but not for
  other fees.

### **Presidents Report – Harvey Pool**

• FFA contributions are coming in and Harvey just got two good contributions from organizations. We are currently at about \$1400.00. Need to keep posting to Facebook. Debi to challenge Llama Marketing Group to donate \$5.00 each which would give us enough money. Harvey would like to get as much as possible for display, such as herd sire displays, etc. Anyone having any banners or other display materials Harvey can use should contact him. We still need some volunteers to help with the booth. The dates of the convention are Oct 29-31.

### Secretary Report - Debi Garvin

- Building listing We still do not have an offer on the building. Suggestion was made to lower the price in an email. Official vote was taken and passed to lower the price to 339,000.
- The application to refinance the building was turned down. The only option now is to get a group of investors to carry the papers on the building. If this was done, ILR would pay 6-7% interest. Ideally 4 people each would put up \$50,000 for a total of \$200,000. They would be carrying the mortgage and payments would be made into escrow and the 4 people would be issued checks each month for the payments.
- Property Management The conditional use for doggy day care is going through. However, we will
  have to put up a bond for the money for the paving to be done next summer.

#### Treasurers Report - Dawn Moore

The new QB computer in the office is having issues and will be sent back to Tiger Direct. This will
further delay Dawn having easy remote access to write checks. Critical check will be hand-written
by Dawn now. Obviously, the computer issues have delayed getting the finances streamlined.
